14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ During 2012 Covanta Holding Corporation ("CVA") made five cash distributions (payable on January 5, April 12, July 6, October 17, and December 26) in the per share amounts of \$0.075, \$0.15, \$0.15, \$0.15, and \$0.15 totalling \$.675/share.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ The above cash distributions are treated as taxable dividends to the extent of the Company's current and accumulated earnings and profits as of the period ending on December 31, 2012. The portion of the cash distributions that are not dividends shall be applied against the basis of the stock. The portion of the distribution that is a return of capital and not a dividend is \$0.33552. Accordingly, the basis of each share of stock held by each shareholder shall be reduced by \$0.33552.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ The portion of the distribution that is not classified as a dividend represents distributions that are in excess of the current and accumulated earnings and profits that have been calculated based on 2012 and prior years.

18 Can any resulting loss be recognized? ▶ No loss should be recognized with respect to the portion of the distribution that represents a return of capital.

19 Provide any other information necessary to implement the adjustment, such as the reportable tax year ▶ The return of capital calculated in item 15 is a revision to the estimated return of capital reported in item 15 of the Form 8937 that was posted to the Company's website on March 1, 2013. The prior estimate of return of capital was calculated based on the most accurate available information at the time of that filing. Covanta Holding Corporation is reporting this updated Form 8937 because it has determined that the amount of the distribution treated as a return of capital with respect to each share of stock has changed. The revised return of capital has been determined based on revised earnings and profits calculated at the time of the filing of the 2012 Federal Income Tax return. The amounts reported in this filing are based on the most accurate available information at the time of this filing. The above information does not constitute tax advice. It is recommended that shareholders consult with their own legal, financial, or tax advisors to consider the consequences of reporting amounts that may be revised at a later date.
