14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ **During 2013 Covanta Holding Corporation ("CVA") made three cash distributions (payable on April 5, July 8, and October 7) in the per share amounts of \$0.165, \$0.165, and \$0.165 totalling \$0.495 per share.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **The above cash distributions are treated as taxable dividends to the extent of the Company's current and accumulated earnings and profits as of the period ending on December 31, 2013. During 2013 forecasted current earnings and profits calculations indicated that all 2013 cash distributions would be treated as dividends and no portion of the cash distributions would be treated as a return of capital. That changed later in January 2014 when the Company calculated current earnings for financial reporting for the year at which time earnings and profits were calculated. It was then determined that a portion of the cash distributions in 2013 were not dividends and shall be applied against the basis of the stock. The portion of the distribution that is a return of capital and not a dividend is \$0.09999. Accordingly, the basis of each share of stock held by each shareholder shall be reduced by \$0.09999.**

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ **The portion of the distribution that is not classified as a dividend represents distributions that are in excess of the current and accumulated earnings and profits that have been calculated based on 2013 and prior years.**

It is likely that updated information will be available when the 2013 Federal Income Tax return has been finalized at which time an updated Form 8937 may be filed.
